## **OFFICIAL RULES AND REGULATIONS**

### **Mail-in Offer – Free Commensal Lunch Bag**

1. This mail-in consumer offer (hereinafter “the Offer”) is held by and to the advantage of Commensal s.e.c. It takes place in participating stores across the province of Quebec until December 14<sup>th</sup>, 2008 or as long as supplies last. Entries postmarked later than this date will be null and void.
2. The Offer will not be sent to any consumer who fails to comply with any one of the aforementioned conditions or any other condition stipulated in the present rules.
3. Proofs of purchase (bar codes of the products) are subject to verification by the Offer organizers. No reproductions of any kind will be accepted. If any proof of purchase submitted is not original, it will be automatically rejected and will not be counted as one of four proofs of purchase applicable towards obtaining a Free Lunch Bag. Furthermore, proofs of purchase will be declared invalid and will not count towards obtaining a Free Lunch Bag if they are transmitted late, mechanically reproduced, mutilated, forged, falsified, altered or tampered with in any way. Entrants agree to abide by the Offer rules and the decisions of the Offer organizers, which are final.
4. In the event of a printing defect on a bar code of a Commensal product — meaning if the entry information does not comply with the essential characteristics stipulated within the present rules and regulations, thus obstructing the right of the consumer to receive the

Offer — the organizers' responsibility is null and void and this bar code will not be accepted. Any attempted fraud connected with participation in the Offer using this procedure will automatically disqualify the consumer for the entire duration of the Offer.

5. The consumer who receives a Lunch Bag releases Commensal s.e.c., its affiliated companies, participating stores, their advertising and promotion agencies, and any party involved in the present Offer from all responsibility for any damages that may occur as a result of the acceptance or use of the Lunch Bag.
6. The Offer organizers will deliver the Free Lunch Bag to the eligible consumer within a period of six to eight weeks.
7. All Lunch Bags must be accepted as awarded.
8. The Offer organizers will not assume any responsibility for any postage or handling errors or late entry claims, whether these were sent late by the consumer or received late for any reason beyond the consumer's control.

The Offer organizers reserve the right, at their sole discretion, to cancel, terminate, modify or suspend the present Offer, in whole or in part, in the case of any event or human intervention that may corrupt or affect the Offer management, security, impartiality or progress as provided in the present rules.
10. This Offer is subject to all applicable provincial and municipal laws.
11. For the purposes of the present rules, the consumer is the person whose name appears on the Order Form.
12. In case of discrepancy between the French and English versions of the present rules, the French version will prevail.
13. There is a limit of one entry per person per address.
